### Waiver and Release of Liability

I understand that yoga includes physical movements, as well as an opportunity for relaxation, stress reduction, and relief of muscular tension. As is the case with any physical activity, the risk of injury, even serious or disabling, is always present and cannot be entirely eliminated. If I experience any pain or discomfort, I will listen to my body, adjust or come out of the posture, and ask for support from the teacher. I hereby assume the entire risk of any personal physical or psychological injury, damage, loss, harm, death, claim, medical expenses and any other type of expense that might occur during or as a result of my participation in Spiral Path Yoga Center classes or activities, or for any accidents that may occur on the premises. I agree that Spiral Path Yoga Center is in no way responsible for the safekeeping of my personal belongings while I am on the premises, or if I leave a personal item behind.

I agree to keep my yoga teachers apprised of any changes in my health that may be relevant to my yoga practice and safety in class, understanding that the teachers and studio will hold this information as confidential. Yoga and Yoga Therapy are not substitutes for medical or psychological care, examination, diagnosis, or treatment. Yoga and meditation may not be recommended or safe under certain medical or psychological conditions. I affirm that I alone am responsible to decide to practice yoga and meditation. I hereby agree to irrevocably release and waive any claims that I, my family members, heirs, or legal representatives, may have now or hereafter have against Spiral Path Yoga, LLC (dba Spiral Path Yoga Center), its owners, members, employees, and contractors. I release, waive, discharge, and covenant not to sue or exercise legal right to seek damages from Spiral Path Yoga for any injury or undesirable consequence of yoga and meditation practice, whether due to accident, negligence, or other cause. I understand that this agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion of the Agreement is held invalid, it is agreed that the balance shall continue in full legal force and effect.

### Cancellation and Refund Policy for Classes & Workshops, Return Policy for Retail Items

There are no refunds for classes. All packages and memberships are non-refundable, including single classes, all multi-class passes, monthly and annual unlimited memberships. Passes are for a single student only and cannot be shared. Class passes are transferable only under special circumstances and may require a transfer fee. Multi-class packages shall be used within a 365-day period from the purchase date. We reserve the right to change the schedule or cancel any class or program due to insufficient enrollment or unforeseen circumstances. Passes are not refundable due to regular class cancellations or schedule/teacher changes. In the event of workshop or training cancellation, registrants will be notified in advance and full refunds or credits will be issued. Studio account credits will be given for workshop cancellation made by student, if prior to 24 hours from workshop time. No credit is given for late cancellation or non-attendance by the student. Exchanges and account credits are available only for items in original packaging with original tags, returned within 30 days of purchase. Opened or used items and sale items may not be returned.
